6. Provide a clean, clear copy of the dated **Invoice** or **Packing Slip**. (The eligible product's purchase item, purchase date, and full address must be listed on the invoice or packing slip)
7. Mail all these item (**ICY DOCK MIR Online Submission Form, Original UPC and Invoice or Packing List**) to the address shown in below. Submission must be postmarked within **20 days** of the invoice date
